Pending disposal of the aforesaid Writ Appeal it is hereby ordered by the Hon'ble Division Bench on
Thursday THE 19 DAY OF June 2008

PRESENT

The Hon'ble Mr. CYRIAC JOSEPH, CHIEF JUSTICE
AND
The Hon'ble Mr. Justice A.N.VENUGOPALA GOWDA

Having heard learned counsel for the parties and having considered the facts and circumstances of the case, we are of the view that the Government should be given liberty to take appropriate action in accordance with law on the report submitted by the Lok Ayukta. If and when such action is taken by the Government, the aggrieved persons can seek redressal of grievance, if any. Prima facie, we are of the view that the learned Single Judge was not justified inhibiting the power and discretion of the Government in dealing with the report of the Lok Ayukta as required by law. Hence the operation of the impugned order of the learned Single Judge is stayed until further orders. We make it clear that it is open to the Government to consider the report of the Lok Ayukta and take appropriate action in



accordance with law. We also make it clear that this stay order will not stand in the way of the Bruhat Bangalore mahanagara Palike or any other statutory authority implementing the provisions of the Karnataka Municipal Corporation Act, 1976 or the Prevention of cruelty to Animals Act, 1960.
