THIS WP is filed under Article 226 of the  
Constitution praying to direct the Corporation  
of the City of Bangalore to execute and implement  
its new project of establishment of new dog pound  
at Bommasandra, Bangalore expeditiously and in  
accordance with the provisions of the Karnataka  
Municipal Corporations Act of 1976 and the Prevention  
of Cruelty to Animals Act of 1960 and etc.,

ORDER

Needful has not been done despite opportunities granted.

2. In this petition filed in Public Interest, prayer has been made for issuance of directions to the Corporation of the City of Bangalore to execute and implement its new project of establishment of new dog pound at Bommasandra, Bangalore, and to prevent cruelty to the stray dogs and other dogs and to take necessary steps for preventing and avoiding cruelty to the animals.

3. In the statement of objections filed on behalf of the respondent-1, it is submitted that stray dogs are caught and kept in cages in the interest of the public in order to prevent dreadful diseases like rabies etc. The dogs are caught by wire loop method and impounded in the pound maintained by the Corporation. The dogs are numbered daywise. Learned counsel for the respondents submits that the practice of electruting the dogs after three days has been abandoned and as a routine ~~if~~ such dogs which are not cleaned are sterilised. Only dangerous and diseased dogs are electruted.

The Number of cages are said to have been constructed which are being properly maintained with the provision of water supply. The construction of modern dog pound has been included in the programme of works to be constructed by the Corporation. It is further submitted that at present instead of the Corporation, an Organisation known as COMPASSIONATE UNLIMITED PLUS ACTION (CUPA) is taking care of the stray dogs.

4. In view of the statement of objections and the statements made at the Bar, no action is required to be taken in the matter and the petition is disposed of as settled. /
