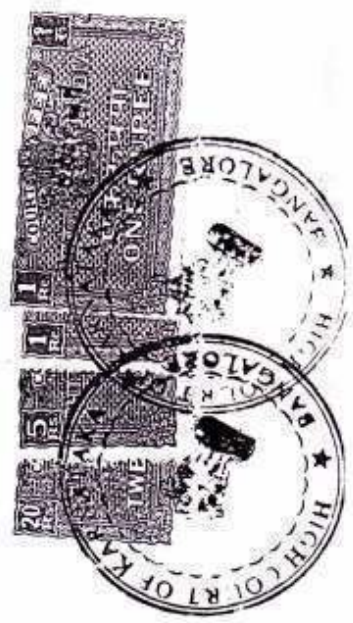

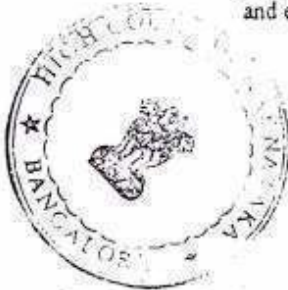

W.P.No.1970/2001 is filed under Article 226 and 227 of the Constitution of India praying to direct the Respondent to round up all the stray dogs of Bangalore City and sterilize all stray dogs, and etc.,

These Writ Appeals coming on for preliminary hearing this day, the Chief Justice made the following:



ORDER

One Stray Dog free Bangalore, a Society registered under the Karnataka Societies Registration Act and others have filed this PIL alleging stray dog menace in Bangalore City. It is stated that the Karnataka Municipal Corporation Act makes it an obligatory duty of the Bangalore Mahanagara Palike, the second respondent herein, to detain and destroy the stray dogs. It does not provide for allowing the dogs to stray again as is being done now contrary to law and at great danger to the health and well being of human beings. It is also stated that the respondents have arbitrarily and illegally and without justification failed to perform their statutory and constitutional duties to the residents of Bangalore. Through this PIL, the petitioners have sought for a direction to the respondents to enforce the provisions of the Karnataka Municipal Corporations Act, 1976 and the Karnataka Police Act, 1963 and to catch and eliminate the menace of stray dogs in the City of Bangalore; to discontinue the use of semple or nerve tissue vaccine and provide adequate quantities of serum or immunoglobuline and tissue culture vaccines to the victims of dog bites in the various Clinics, Health centres and other Hospitals and facilities maintained by them, among other reliefs.

2. In response to the notice, Mr. Ashok Dalwai, Commissioner, Bangalore Mahanagara Palike, filed his affidavit. The Bangalore Mahanagara Palike has adopted a system wherein the dogs are caught, sterilized, confined and euthanised depending on the situation. The

Bangalore Mahanagara Palike is monitoring the entire activity after taking the assistance of the NGOs. It is stated that he has filed a detailed affidavit in W.P.No.1970/2001 indicating the existing system of dealing with stray dogs. The Bangalore Mahanagara Palike has adopted a system wherein the dogs are caught, sterilized, confined and euthanized depending on the situation. Bangalore Mahanagara Palike monitors the entire activity after taking the assistance of the NGOs. It has also proposed to confine dogs in certain cases in respect of which the Corporation is proposing to set up animal refuge centre. A regular program has been chalked out by Bangalore Mahanagara Palike with the involvement of NGOs.

3. It is also stated that a Monitoring Committee has been constituted which guides the NGOs. for taking corrective action and for better management and it meets once in a month and decisions taken therein are implemented by Bangalore Mahanagara Palike and the NGOs. The details of the stray dogs caught, the number of dogs sterilized and number of dogs euthanized are clearly stated vide Annexure-R.1. The performance of the NGOs. during the period October, 2001 to January, 2002 is separately listed vide Annexure-R.2 and that the details of the number of dogs caught by CUPA, SPCA AND THE Animal Rights Fund are produced vide Annexures R.3 to R.5.

4. Bangalore Mahanagara Palike is taking all possible steps to control the menace of stray dogs with the assistance of NGOs. and the Monitoring

Committee consisting of Commissioner, Chief Health Officer, Zonal Health Officer, representative of NGOs, Professor and Assistant Professor of Anti-rabies Centres, KIMS etc., is constantly monitoring the stray dogs control program. A memo is also filed by the learned Counsel for the second respondent producing a copy of the Action Taken Report pertaining to controlling the menace of the stray dogs in Bangalore, for the period from March, 2002 to June, 2002 for perusal of this Court.

3. We have heard the learned counsel for the parties and perused the materials placed on record.

4. On consideration and in view of the submission, when the authorities concerned have taken all such precautionary measures to control the stray dog menace and is constantly monitoring the stray dog control program, it is not necessary to pass any specific order.

Writ Petitions are disposed of. However, it is expected that the authorities concerned will go on monitoring the stray dog control program.
